ADMINISTRATIVE ORDER NO. 385

RECONSTITUTING THE EXECUTIVE COMMITTEE CREATED TO TAKE CHARGE OF THE PREPARATION AND ARRANGEMENTS FOR THE HOLDING OF THE FOURTH WORLD CONGRESS ON MEDICAL LAW IN MANILA ON JULY 16-19, 1976.
