PROCLAMATION No. 373

AMENDING PROCLAMATION NO. 42, SERIES OF 1954,
BY REDUCING THE AREA OF THE LAND RE-
SERVED THEREIN FOR THE QUEZON MEMO-
RIAL PARK IN DILIMAN, QUEZON CITY, AND
REVERTING THE EXCESS TO THE PEOPLE'S
HOMESITE AND HOUSING CORPORATION

Upon the recommendation of the Secretary of Agriculture and Natural Resources as Chairman of the Commission on Parks and Wildlife, and pursuant to the provisions of section One of Act Numbered Thirty-nine hundred and fifteen, as amended, and of section Two of Republic Act Numbered Eight hundred and twenty-six, I, Ramon Mag-saysay, President of the Philippines, do hereby amend Proclamation No. 42, dated July 5, 1954, by reducing the area of the land reserved therein for national park

purposes to be known as Quezon Memorial Park, under the administration of the Commission on Parks and Wildlife, so as to include only the following four (4) parcels situated in Diliman, Quezon City, and more particularly described as follows, to wit:
