PROCLAMATION NO. 166

ESTABLISHING AS NATONIN FOREST RESERVE FOR WOOD PRODUCTION, WATERSHED, SOIL PROTECTION AND OTHER FOREST USES, THE PARCELS OF PUBLIC DOMAIN KNOWN AS TIMBERLAND, ISABELA BONTOC, AND IFUGAO LAND CLASSIFICATION PROJECT NOS. 13-B, 10-B, 10-B and 5-F, PER B.F. MAP LC.-2296, SITUATED IN THE MUNICIPALITIES OF ROXAS, NATONIN AND MAYOYAO, PROVINCES OF ISABELA AND MOUNTAIN PROVINCE, PHILIPPINES.

Upon recommendation of the Director of Forestry, approved by the Secretary of Agriculture and Natural Resources, and pursuant to the provisions of Section 1826 of the Revised Administrative Code, as amended by Republic Act No. 5092, I, FERDINAND E. MARCOS, President of the Philippines, do hereby withdraw from entry, sale, settlement or other disposition and establish and proclaim as NATONIN FOREST RESERVE, subject to private rights, if any there be, the parcels of public domain known as Timberland, Isabela, Bontoc and Ifugao Land Classification Project Nos. 13-B, 10-B and 5-F situated in the Municipalities of Roxas, Natonin and Mayoayao, Province of Isabela and Mountain Province, demarcated and established under Forestry Administrative Order No. 4-814, dated March 26, 1962, for wood production, watershed, soil protection and other forest purposes under the administration and control of the Director of Forestry who shall have the authority to regulate the use and occupancy of said forest reserve and the cutting, collection and removal of timber and other forest products therein in accordance with forest laws and regulations.

The aforementioned parcels of public domain are shown and more particularly described in the attached Bureau of Forestry Map L.C.-2296, comprising the Timberland of the aforementioned Isabela, Bontoc and Ifugao Land Classification Project Nos. 13-B, 10-B and 5-F, respectively, containing an aggregate area of SEVEN THOUSAND EIGHT HUNDRED THIRTY SIX (7,836) HECTARES, more or less.
