PROCLAMATION NO. 184

RESERVING FOR SCHOOL SITE PURPOSES OF THE PALAWAN STATE COLLEGE A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN THE BARRIO OF TINIGUIBAN, CITY OF PUERTO PRINCESA, ISLAND OF PALAWAN.

Upon recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me by law, I, CORAZON C. AQUINO, President of the Philippines, do hereby withdraw from sale or settlement and reserve for school site purposes under the administration of the Department of Education, Culture and Sports, subject to private rights, if any there be, a certain parcel of land of the public domain situated in Barrio Tiniguiban, City of Puerto Princesa, Island of Palawan, which parcel is more particularly described as follows:

"A PARCEL OF LAND (Plan NR-04-000010-D) situated in Barrio Tiniguiban, City of Puerto Princesa, Island of Palawan, Bounded on the N., along line 1-2 by Lot 3; on the N., NE., along lines 2-3-4-5-6-7-8 by Bureau of Plant Industry; on the SE., S. & SW., along lines 8-9-10-11-12-13-14-15-16-17-18-19-20-21-22-23-24-25-26-27-28-29-30-31-32 by Puerto Princesa Bay; and on the W., along line 32-1 by Lot 2. Beginning at a point marked "1" of plan NR-04-000010-D, being N. 27 deg. 46'W., 2248.14 m. from BLM No. 1, Bo. Tiniguiban, Puerto Princesa City;

All points referred to are indicated on the plan and are marked on the ground as follows: point 1, 2, 3, 4, 5, 6, 7 & 8 by Old B.L. Cyl. conc. mons., and the rest by Stakes. The lot was surveyed in accordance with law and existing regulations promulgated thereunder, by Eduardo R. Salvador, Geodetic Engineer, on November 19, and December 4, 1974 and approved on October 28, 1975.
