PROCLAMATION NO. 784

RESERVING FOR MILITARY USE PURPOSES OF THE PHILIPPINE AIR FORCE, DEPARTMENT OF NATIONAL DEFENSE, A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN THE CITY OF LAPU-LAPU, PROVINCE OF CEBU

Upon recommendation of the Secretary of the Department of Environment and Natural Resources and by virtue of the powers vested in me by law, **I, FIDEL V. RAMOS**, President of the Republic of the Philippines, do hereby withdraw from sale, entry, disposition or settlement and reserve for military use purposes of the Philippine Air Force, Department of National Defense, subject to private rights, if any there be, a certain parcel of land of the public domain, situated in the City of Lapu-lapu, Province of Cebu, which is particularly described as follows:

SK-07-000010
(Philippine Air Force)

A PARCEL OF LAND (SK-07-000010, Proposed DND-AFP Reservation), situated in the barrio of Canjulao, City of Lapu-lapu, Province of Cebu, Island of Cebu.

Bounded on the N.W., along lines 1 to 7 by Lot 2515; along lines 7 to 13 by Lot 2518; along lines 13 to 31 by Lot 2495; along lines 31 to 37 by Lot 2486; and along lines 37 to 44 by Lot 2474, all of Opon Cadastre; on the NE., along lines 44 to 52 by Road; on the E., along lines 52 to 56 by Mactan International Airport, on the SE., along lines 56 to 57 by Airplane Landing; on the SW., along line 57-58 by Metrofil Site; along line 58-59 by Road; on the SW., along line 59-60 by Officer's Village; on the W., along lines 60-64 by Lot 709; along lines 64-67 by Lot 901; along line 67-68 by Road; along line 68-69 by Lot 815-A; along lines 69-75 by Lot 815; and along lines 75-76-1 by Road; all of Opon Cadastre.
