PROCLAMATION NO. 1258

**AMENDING PROCLAMATION NO. 156 (S. 1994) CLASSIFYING THE LINGAYEN GULF AS AN ENVIRONMENTALLY CRITICAL AREA, AND SEGREGATING SOME PARCELS OF LAND OF THE PUBLIC DOMAIN THEREFROM AND RESERVING THE SAME FOR ECOTOURISM AND OTHER SUSTAINABLE DEVELOPMENT PROJECTS AND ACTIVITIES OF THE PROVINCE OF PANGASINAN**

Upon recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me by law, I, **FIDEL V. RAMOS**, President of the Philippines, do hereby amend Proclamation No. 156 dated 25 March 1994, designating the Lingayen Gulf as an environmentally critical area, and segregating the following parcels of public land therefrom, situated in Barangays Sabangan, Estanza, Malimpuec and Capandanan, Municipality of Lingayen, Province of Pangasinan, subject to actual cadastral survey, private rights and their appropriate land use; and reserving the same for ecotourism and other sustainable development activities and/or projects of the Provincial Government of Pangasinan:

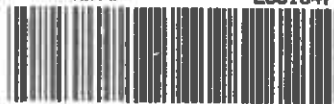
**A PARCEL OF LAND** as shown on Plan Nr 01-00029, Barangays Sabangan, Estanza, Malimpuec, and Capandanan, Municipality of Lingayen, Province of Pangasinan, Island of Luzon. Bounded on the SW, along line 1-2-3-4-5-6 by Barangay Sabangan, on the West, along line 6-7 by a public land; on the North, along lines 7-8-9-10-11-12-13-14-15-16-17-18-19-20-21-22-23-24-25-26-27-28-29-30-31-32-33-34 by a 50-meter wide Salvage Zone and Lingayen Gulf; on the East, along lines 34-35 by an unclassified public land and the Limahong Channel; on the Southeast along lines 35-36 by portions of Barangays Capandanan and on the South, along lines 36-44 by Barangay Malimpuec; along lines 44-01 by portions of Barangays Malimpuec and Estanza. Beginning at point marked "1" of the said plan, identical to BBM No. 15, Cad-373-D, Lingayen, Pangasinan,


