**BY THE PRESIDENT OF THE PHILIPPINES**

**PROCLAMATION NO. 784**

**DECLARING AS CIVIL RESERVATION FOR SCHOOL SITE PURPOSES  
OF THE BARRA ELEMENTARY AND NATIONAL HIGH SCHOOLS,  
CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED  
IN BARRA, DIPOLOG CITY, PROVINCE OF ZAMBOANGA DEL  
NORTE, ISLAND OF MINDANAO.**

Upon recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me by law, I **GLORIA MACAPAGAL ARROYO**, President of the Republic of the Philippines, do hereby declare as civil reservation for school site purposes of the Barra Elementary and High Schools under the administration of the Department of Education, a certain parcel of land of the public domain situated in Barra, Dipolog City, Province of Zamboanga del Norte, Island of Mindanao, subject to private rights, if any there be, which parcel of land is more particularly described as follows:

**LOT 1, SGS-09-000639**

A PARCEL OF LAND, (Lot 1, Sgs-09-000639, being a portion of Lot 914, Cad-85, situated in Barra, Dipolog City, Province of Zamboanga del Norte, Island of Mindanao.

Bounded on the SW., along line 1-2 by Lot No. 19; along line 2-3 by Lot No. 18; along line 3-4 by Lot No. 17, all of Cad-85; along line 4-5 by Quezon Avenue; along line 5-6 by Lot No. 16; along line 6-7 by Lot No. 15 along line 7-8 by Lot No. 14, all of Cad-85; on the NW., along lines 8-9-10 by Burgos Street (existing concrete road); on the NE., along line 10-11 by Lot No. 7, Sgs-4126; and on the SE., along line 11-1 by Balintawak Street (Extension), being a portion of Lot No. 914, Cad-85, Dipolog Cadastre.

Beginning at point marked "1" on plan being N. 56 deg. 57' E., 535.77 meters from BLLM No. 1, Cad 85, Dipolog Cadastre, thence:

Mons. 15 x 60 cms. Bearings Grid; Date of Survey April 26-27, 2001 and was approved on December 3, 2003.
