

BY THE PRESIDENT OF THE PHILIPPINES

PROCLAMATION NO. 818

DECLARING AS CIVIL RESERVATION FOR SCHOOL SITE PURPOSES OF ASIPULO NATIONAL HIGH SCHOOL, A CERTAIN PARCEL OF LAND LOCATED IN BARANGAY ANTIPOLO, MUNICIPALITY OF ASIPULO, PROVINCE OF IFUGAO, ISLAND OF LUZON

Upon recommendation of the Secretary of Environment and Natural Resources, and by virtue of the powers vested in me by law, **I, GLORIA MACAPAGAL ARROYO**, President of the Republic of the Philippines, do hereby declare as civil reservation for school site purposes of Asipulo National High School under the administration of the Department of Education, a certain parcel of land of public domain situated at Municipality of Asipulo, Province of Ifugao, Island of Luzon, containing an area of **Ten Thousand Three Hundred Forty Seven (10,347) square meters**, subject to private rights, if any there be, which parcel of land is more particularly described as follows:

PLAN SWO-CAR-000686

A PARCEL OF LAND (Plan SWO-CAR-000686), situated at Barangay Antipolo, Municipality of Asipulo, Province of Ifugao, Island of Luzon.

Bounded on the NW., along line 1-2 and on the NE., along lines 2-3-4 by Fernando Dupingay; on the NE., along line 4-5 by Noel Piggangay; along lines 5-6-7-8-9 by Andres Allawa; on the SE., along line 9-10 by Raymundo Binbinon and Pathway; on the SW., along lines 10-11-12-13 by Ernesto Puh-no; along lines 13-14-15-16-17-18 by Jane Collado; on the SE., along lines 18-19-20-21 by Alfonso Lomlom; along lines 21-22-23 by Armando Domilod; on the West along lines 23-24-25 by Road; and on the NW., along line 25-1 by Fernando Dupingay.
